## CASS COUNTY BOARD OF COMMISSIONERS REGULAR MEETING

#### **December 15, 2016**

The County Board of Commissioners met in regular session Thursday, December 15, 2016 in the Cass County Commission Chambers.

Chairperson Bernie Williamson called the meeting to order at 7:00 p.m. Commissioner Marchetti provided the Invocation. Commissioner Cobb led the Pledge of Allegiance to the Flag of the United States of America.

#### APPROVAL OF THE AGENDA

Commissioner Ziliak moved, seconded by Commissioner Marchetti, to approve the December 15, 2016 Board of Commissioners Regular Meeting Agenda.

#### **PRESENTATIONS**

Maintenance Director Dave Dickey gave presentation on the air sampling assessment for the Cass County Building. He indicated that sixteen air samples were taken from the Cass County Building and one from outside. The reason the samples had been taken were because employees from the Cass County Building were expressing their concern with the air quality in the building. The Kincheloe Room (Room 120) came back with elevated levels, and room 209 had a visual of mold. Both of the rooms have since been taken care of and have been re-tested. They have come back with levels at acceptable ranges. Dave indicated that if anyone had any questions the gentleman that conducted the tests is available to speak. Discussion followed.
