**RE: CASS COUNTY 1899 HISTORIC COURTHOUSE:
RE-IMAGINED!**

Dear Friend,

Approximately three years ago, three Cass County Commissioners decided it was time to begin engaging the community around re-imagining the 1899 historic courthouse, whose iconic structure in downtown Cassopolis has served as the signature landmark for this Cass County seat of government. The plan for this complex project involving a government owned building was to first determine, through a variety of engagement activities, whether the Cass County community had a desire to save the structure with a repurposed use or demolish it. Almost 90% of the citizens and stakeholders, that wished to be heard, asked that the structure remain.

The second step in the plan required exercising the Board of Commissioners duties pursuant to MCL 46.7 to undertake certain necessary repairs of the historic courthouse to ensure that it remain a viable structure until the final use outcome in this courthouse project is appropriately identified and actualized pursuant to using a fiscally sound and responsible funding mechanism that will best serve the County.

While much has been accomplished, it is time to take the critical next step, which is determining funding sources and mechanisms that will allow for the realistic highest and best use for the space, preservation of certain iconic elements of the structure, all within a fiscal framework that does not have a negative financial burden on the County's general fund or the taxpayers of Cass County. So, what does that look like? Over the course of the next 6 to 10 months, we will take the time and invest the effort to learn about the various funding mechanisms, experts and other financial resources available to Cass County to assist with this very special economic development project.
